The Asian Women Coalition Ending Prostitution (AWCEP) challenges the normalization of human trafficking and prostitution of Asian women in Canada and around the world.

AWCEP joins feminist allies at the Bedford Supreme Court hearing in Ottawa

AWCEP participated as an intervenor before the Supreme Court of Canada at the June 13 Supreme Court hearing of the Bedford case. The court has not released a decision.

The court will decide whether some of the laws relating to brothels and street prostitution offend s.7 of the Canadian Charter. Section 7 says "Everyone has the right to life, liberty and security of the person and the right not to be deprived thereof except in accordance with the principles of fundamental justice."

Current prostitution laws offer women some protection, and make it possible for police to investigate human trafficking, but only if they are applied to men who create the demand for prostitution and not to the prostituted women.

AWCEP is concerned that normalizing brothel keeping and male demand for prostitution will normalize the racism and sexism that impede Asian women's ability to have access to the equal protection of Charter rights, including the right to security of the person. We hope that the critical race analysis we provided will help the court come to a conclusion that takes the racist and sexist impacts on

women into account.
